ADJUSTMENT PROCEDURE FOR:

9200 STS Soft- Touch SHORT HANDLE TOOLS 12" OVERALL LENGTH

This tool is adjusted at the factory and no further adjustment should be required.


Should the tools, through extended use, require adjustment, wear in the parts may be compensated for as follows:

- 1. Close tool handles until pre-load is reached (this is the point at which jaws butt).
- 2. Measure the distance between the autside of the handles at the end of the handle grips. Dim X is the correct distance.
- To increase the pre-load setting, remove the #8-32 eccentric lock screw and rotate counter clockwise to increase the handle pre-load and clockwise to decrease handle pre-load. Re-Install the #8-32 lock screw in the appropriate hale which most clasely yields the desired handle dimension.
- 4. Rechack the set distance after making three crimps.
- 5. Check the crimps with the crimp gauge provide. If satisfactory crimps do not result, the tool is likely worn and should be replaced.

In addition, always remember to:

- 1. Check tool calibration at least daily. It is recommended that at least the first and last crimp of the day are tested.
- 2. Never exceed the specified handle distance when adjusting your crimp tool. Premoture wear will result.
- 3. Lubricate linkages on a regular basis to maximize tool life.


